1. ENTOG Exchange in Poland

The annual ENTOG Exchange is going to take place on 3rd-8th June 2019 in Poland. Traditionally, 2 trainees from each member country are invited to participate in the exchange part and should be selected by the national trainee associations.

The schedule of the ENTOG Exchange is going to be as follows:

- Monday to Thursday: exchange in different hospitals around the country
- Friday: morning workshops + Scientific Meeting entitled
 "Reproductive health & prenatal testing in Europe"
- Saturday: ENTOG Council with elections for the ENTOG Executive and of the host country for the ENTOG Exchange 2021

Remember that there is no limit on the number of trainees to participate in the Scientific Meeting and Council. The invitation letter with more details will be sent soon.
